1 Respective responsibilities of the body and the auditor

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2019/20

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.:

- Section 2, Box 8 does not agree to the bank reconciliation. The figure in Box 8 should read £76,887.
- The smaller authority has not restated the 2018/19 figure when revaluing assets in Section 2, Box 9. Please note that the
 Practitioners' Guide allows smaller authorities to use any reasonable valuation method, provided that the prior year figure is
 restated for consistency and comparability

Other matters not affecting our opinion which we draw to the attention of the authority:

In the prior year, the smaller authority was exempt from our review, thus we have not reviewed any evidence to support the prior year comparatives on the AGAR.

The smaller authority has not provided an adequate explanation for the variance between the prior and current year values in Box 4 and Box 6 lof Section 2.
